# Extension for doctoral students holding elected positions at the NJ Faculty

Elected positions constitute special grounds for extension of a doctoral studentship or another form of employment, and are discussed in Chapter 5, Section 7 and Chapter 6, Section 29 of the Higher Education Ordinance (HF).

A doctoral/PhD student at the NJ Faculty shall have their employment extended by way of compensation for elected positions within faculty bodies and/or ULS PhD student councils, regardless of the form of remuneration. Only positions to which the student is elected can be used as a basis for extension. The extension must be proportionate to the amount of work entailed in the position.

Apart from membership in a faculty body or the ULS PhD Student Council at the NJ Faculty, extensions should also be granted for membership in boards for international and national PhD organisations with a clear mandate for international and/or national coordination and lobbying for PhD students' interests. The level (number of days/years) must follow the Association of Swedish Higher Education's recommended guidelines (see Appendix 1).

The right to an extension is not granted for

- participation in a PhD student council meeting as a non-member/deputy
- participation in a meeting as an adjunct member
- participation in a meeting as a deputy where the regular member is also present (with the exception of a deputy in a doctoral education committee).

The Division of Planning is responsible for elected positions on university-wide boards and councils.

For PhD students without employment, an extension shall be granted in the form of remuneration corresponding to 75% in the doctoral student salary agreement.

Prolongation should only be paid when the doctoral student has attended at least 70 percent of the meetings he or she were called to attend.

## Instructions to departments regarding extension of time and payment of remuneration

- 1. The chair of the PhD student council shall send, on an annual basis in January, a list of the PhD students who have held elected positions at the faculty during the previous year to the education officer for PhD education at the faculty office (forskarutbildning-NJ@slu.se). The chair of the PhD student council shall also inform the PhD students concerned and contact persons for doctoral education at the respective departments.
- 2. The education officer for PhD education at the faculty checks the information and informs the financial officer at the faculty. The financial

- officer at the faculty is responsible for calculating remuneration for elected positions and respective payments to the departments concerned. The departments do not need to request funds from the faculty.
- 3. The PhD student shall inform the department annually of which positions he or she holds. The positions shall be recorded in a document (documentation from the PhD Student Council; see point 1) enclosed with the individual study plan. For reporting activities in Ladok, deductions shall be made corresponding to the days per semester given in the table above.
- 4. At the end of the PhD student's studies, an extension can be granted following the decision of a head of department. This entails the extension of a post/equivalent (exceeding 4 years' net study time) corresponding to the total time during which the PhD student held an elected position during their education.
