1. Opening of the meeting

Maria opened the meeting, and talked about the content and formalities for the meeting.

2. Approval of the agenda

The agenda was approved.

3. Election of chairperson, secretary and person to approve the minutes

Maria was elected as chairperson, *Monika* as secretary and *Christina* was elected to approve the minutes.

4. Approval of notice to attend

It was approved that the notice to attend was sent well in advance.

5. Minutes from SLUSS DN meeting 2016-09-21

The protocol from last meetings (2016-11-01 and 2016-12-09) was approved.

6. Reports from PhD-student councils

Alnarp studentkår (ASK)

Anna-Lovisa reported that a new council has been elected, and that all positions have been filled. Some members now have new positions in the council. New chairperson is Joel Markgren, also PhD student representative in the faculty board. Anna-Lovisa was elected to be secretary in the council, and a person being responsible for the webpage has been elected.

The council is working on a handbook for PhD students and a welcome letter will also be sent out.

The working environment has been discussed. Some people have quite bad offices; crowded and uncomfortable chairs and tables. The council is trying to find out how bad it is. Joel Markgren has suggested that this will be a topic for the faculty board meeting.

The council arranges after work activities every month.

Skogshögskolans studentkår (SHS)

Mattias informed that the annual meeting was held in December, and most of the time went to the election of the board. Several old representatives have new positions. Chair of the board is Clydecia Spitzer.

The newsletter will be evaluated. Now it's distributed through e-mail, but there are discussions about if it should be printed out.

There are ongoing discussions about co-authorship, and also a dialogue with Göran Spong, Faculty director of doctoral education, in this matter.

Mattias also informed us about a research school that has started.

Ultuna studentkår (ULS)

Kristina gave us a report from ULS.

The PhD student handbook is updated, and can also be downloaded from internet. All PhD students should have access to it.

Three departments have merged to the department of Molecular Sciences. It seems to be organized quite well.

In FUR and in FUN "medarbetarsamtal", also for PhD students, has been discussed. Who is their boss? What about PhD students who aren't employed? It should be for all PhD students. Lotta made a suggestion to the deans, and it will be raised in the faculty board with the intention to change the delegation order so it embraces all PhD students.

Veterinärmedicinska föreningen (VMF)

Christina gave us the following information:

VMF had a first meeting of the year last week. A new council was elected. All positions except one are now filled.

"Phd- and post doc fika" are ongoing, and the impression is that it works fine. The council has a new webmaster, Suvi Mäkeläinen, and the web is now updated. SLUSS – SLU:s Samlade Studentkårer SLUSS Doktorandnämnd Protokoll Page **4** of **21**



7. Information from Biostokastikum

Johannes reported that there have been no new meetings with the steering group since last SLUSS DN meeting. Next meeting will take place on Friday 3rd of March.

Discussions in SLUSS DN followed about opportunities to arrange workshops. It's possible, and it's up to the users to decide themes.

8. Information from DO

Monika informed that there have been some new PhD students, but also some "old" who have been in touch since last DN meeting.

Yesterday DO held a lunch seminar for supervisors at the Department of Clinical Sciences about supervisory teams and conflicts within the teams. Other seminars with other themes are also planned for and booked during spring.

9. Information from SLUSS

Isabella reported from SLUSS.

One main issue discussed is gender, and making people more aware of gender issues, for example when recruiting new staff. (See also report from SLU and FUR!)

A recent report from UKÄ about student influence has been released. The report shows that now, when the student union membership is no longer mandatory, many unions become more dependent on the universities than before. *Isabella* pointed out the vulnerability if the university withdraws financing. She also noticed the tendency that there is a focus on recruiting members instead of improving the education. She mentioned a problem from a democratic point of view with few members, when all students should be represented.

The UKÄ report also indicates that there is a lack of knowledge about regulations in some student unions, even though at SLU it's not as bad as in many other student unions.

The work with the future plats forms at SLU is ongoing. The platforms should be a place for a dialog with society, and to identify need of knowledge and research questions within the field. Also students should be involved. Isabella has been in touch with the "future animal and health".

10. Report from SLU board meeting 2016-12-15

Maria reported from SLU-board meeting that took place 15th of December 2016:

- The internal auditing (internrevisionen) at SLU presented a plan for their work 2017. They will look at the management and control of the departments. They will also look into how SLU prevents and investigates irregularities/frauds. The role as director of studies should ideally be more or less the same, but varies between faculties, and this is something to investigate further and come with suggestions for harmonization.
- SLU has great plans on improving the alumni activities. Activities should be arranged with individuals in mind and focus on how he/she can contribute to SLU. Funding is in place, and at least one person will work with this.
- The SLU board decided on the guidelines for our funds. The major changes concerned investments in share should correspond to $60\% \pm 10\%$ and interest bearing investments 40 5 \pm 10%, previously 50:50. Also it was decided that investments in fossil energy, military equipment, tobacco etc. should not be done.
- The research bill (Forskningspropositionen) for 2016 declares that the universities will be assigned funds based on publications, citations, the amount of external funding and also, new for this year, external collaborations (samverkan). This is believed to be positive for us since SLU already have a lot of collaborations.
- Bengt Gerdin, investigating the VH faculty and the animal hospital (UDS), gave a
 brief report on his work so far, the interviews they have had and what he sees as
 main issues, but also great opportunities for the future. A final report will be
 presented to the board in February 2017.
- A new pro-vice chancellor (vicerrektor), Ylva Hillbur, has been recruited with responsibility for internationalization.
- As by 1st of May 2017 SLU will officially have a new board, some however hope to be reelected for another three years. New representatives for the teachers and researchers are Jan Bengtsson, Ingrid Sarlöv-Herlin and Göran Spong.
- SLU was founded in 1977 and next autumn SLU will celebrate 40 years!

11. SLU board meeting Uppsala 2017-02-20

Maria also informed us about the upcoming SLU board meeting in Uppsala on the 20th of February 2017:

- Most time will be spent on the annual revision for 2016. SLU summarize what's been done during the year and the report will be sent to the government.
- Last year 95 PhD students were recruited, which is pretty low. There are now about 600 active PhD students at SLU. Around 70 percent of them are employed PhD students, about 57 percent of them are women; and about 40 percent are non-Swedish students. In average it takes 8,5 semesters to complete the PhD education, which is good.
- The budget proposal for the coming year will also be on the agenda. Bio based material, sustainable food production, economy, importance for animal for wellbeing, antibiotics and antimicrobial resistance are areas that SLU especially hope to receive funding for.
- The internal audit will present a report. This report is about how decisions are handled in the faculty board. According to the internal audit there are difficulties about conflicts of interests.
- Issues regarding advertisements are also on the agenda. The faculty board is responsible for writing the advertisement, and sometimes the ad is really narrow, and written with a specific person in mind.
- Last year a staff survey was performed, and the results from this study will be presented during next meeting.

12. Election of a Vice chairperson for SLUSS DN

Maria will go on parental leave, and a vice chairperson for SLUSS DN should be elected. A discussion followed, and the representatives in SLUSS DN came to the conclusion that it's best to elect someone who is already in SLUSS DN. For the vice chairperson elected the working task is mainly to be chair of the video meeting in May-June. Maria is planning to be back part time after the summer, but it can also be later.

<u>Decision:</u> Mattias was elected to be the vice chair for SLUSS DN for 2017.

13. PhD student representatives 2017

Isabella gave a brief introduction and presented extracts from The Swedish Higher Education Act that involves PhD student representatives. In chapter 1 section 4 it's stated that students shall be entitled to exert influence over the courses and study programs, and that the higher education institutions shall endeavor to enable students to play an active role in the continued development of courses and study programs.

In chapter 2 section 7 the students' right to representation is stated when decisions or preparations are made that have bearing on their courses or programs or the situation of students.

In section 8 it's specified about that a student representative should represent all students, including members and non-members of the union.

Students representatives are elected by SLUSS, and therefore we have the student representative list.

Isabella also presented a slide about in what bodies at SLU there are student- and PhD student representatives and how many in each one of them. Also the labor unions often have the right to attend.

In the activity plan for SLUSS it has been added a wish for a better communication with the PhD councils. In theory it would be possible for the PhD's to have an own PhD union, but in that case it would be quite a process, and a huge amount of administrative work.

Maria presented the PhD student representative list of 2017. Most of the positions are already filled, but some information was added, for example that Mattias now is the vice chair of SLUSS DN.

Decision: The updated list was approved, see Appendix 1.

14. Collaboration with the trade unions

Maria referred to the activity plan, and brought up that, according to the plan, we should collaborate with the labor unions. Today there is not so much collaboration. Anna-Lovisa believes that they will have a lunch seminar with the trade union, but the other councils have no activities planned.

Discussions followed about what kind of activities. Themes that came up during the SLUSS DN meeting were working environment, LAS and other regulations. The role of the Job Security Foundation (Trygghetsstiftelsen) was also discussed.

<u>Decision:</u> Maria will get in touch with some of the trade unions and discuss seminars within the suggested themes.

15. Communication

Maria raised a question about improving the communication between the meetings. She would like to know more about what's going on in the councils and in meetings where the representatives are participating. Also communication with SLUSS was mentioned. Discussion followed about how the communication can be improved on different levels. Representatives from the PhD councils mentioned that they didn't get much information from SLUSS or the student unions, but on the other hand, as Isabella pointed out, if SLUSS doesn't see that information is requested it will probably not be sent out. Since much of the information from SLUSS is in Swedish the distribution in English could be improved but, as mentioned, in order to put effort into translate it, an expressed wish about it is desired.

Maria encouraged the PhD student councils to be in contacts with the student unions.

<u>Decision:</u> The representatives for the councils will check with their councils about distributing the minutes from the PhD council meetings, and then the intention is to distribute the minutes from the PhD council meetings to all in SLUSS DN as a first step.

16. Information from SLU and FUR

Lotta gave us a report.

One main issue discussed in FUR that will also be on the agenda for next FUR-meeting is the revision of the guidelines. There are questions regarding implementation coming up. How are the guidelines interpreted? How are they implemented? Comparisons will be made.

A question discussed was pre evaluation of the thesis, an issue that was already discussed in FUR one year ago. Then it was concluded that the process shouldn't be centrally regulated in the guidelines, but now it's time to compare experiences from the faculties. As far as Lotta knows LTV is the only faculty having standards with an internal evaluation, however without sharp criteria.

Another large question is the general courses. At last meeting it was decided to discuss, evaluate and revise general basic courses, financed centrally.

Consequences of the results from the national PhD survey (Doktorandspegeln) were other issues on the agenda. A discussion has been started. An idea is to evaluate the supervisors. They have the formal requirements to be supervisors, and to evaluate the individual performances of supervisors is rather delicate. There are ongoing discussions and more discussions to come about performing a survey about how supervisors think about their mission.

There are also a lot of discussions on gender mainstreaming since we have to deliver an action plan about what we are doing in terms of gender consciousness in the organization.

17. Update PhD student survey

Lotta informed us that since last time she has changed some things in the content and excluded most of the questions that were in doktorandspegeln (national PhD student survey) since we already know the answers. The survey will be shorter than before. The questions in the upcoming survey will also better meet what's requested from the new quality system that will be used. The SLU survey has been performed four times before. This time the same answering options as in doktorandspegeln will be used, because it makes it easier to compare with the national study. That means that the 10-scale will be abandoned, and four answering options will be used instead.

Lotta has the impression that the interest from people responsible for PhD education are more interested now since we have the common university guidelines, and we are now more one university.

Lotta assume that the survey will be available in two weeks' time.

18. Prolongation

Maria introduced a discussion about prolongation, and asked for some clarifications.

Lotta stressed that all faculties should have guidelines on their websites with instructions for prolongation. For information on prolongation at central SLU-level, Lotta is to be contacted. It not regulated what time of the year the applications for

prolongation can be sent in, or at what stage of the PhD education program one can do it, so it's possible to apply for prolongation at different stages during the years.

19. Information from NOVA

Sophia told us that since last SLUSS DN meeting, there haven't been any NOVA meetings, but there are some small updates. One is that there are a lot of new courses that have been announced. Sophia has sent out an advertisement about it. She is planning to keep track on course dates and deadlines for different courses, and has the intention to send out a reminder through e-mail before deadlines. The representatives in SLUSS were all positive to this initiative.

Sophia has been chosen to be BOVA coordinator/contact person.

Sophia also informed that teachers can apply for funding to organize courses, and emphasized the importance of making potential teachers aware of this.

20. Information from FOMAR

Sophia has been to her first meeting and she is now getting into it. One of the most interesting news is that it's now official that the careers track for environmental analysts (miljöanalytiker) has been approved.

SLU is working on signing agreements with other environmental organizations that SLU is working with. An idea is to create opportunities for PhD students to get a position as "myndighetsdoktorander", comparable to what the industrial PhD students have.

FOMAR's budget has been cut, but as a response to this a campaign has been started called \pm 20 in order to get some funding for activities.

21. Other issues

Maria reminded to renew the membership to the student unions and the membership card. There have been some administrative problems with the new system, but if there will be more problems one can turn to the specific student union in order to get help.

A lot of research is produced at SLU, but much of it does not reach a general public even though it could be of interest for a broader public. *Kristina* suggested that

Ajibola "Jib" Omokanye, founder of Explain artist, should be invited to give a seminar at SLU about how to get the message/research out to the general public. All representatives were positive. *Isabella* mentioned that funding for such seminar could be possible from SLU; the vice-chancellor or FUR.

Decision: Kristina will contact "Jib" and discuss it further.

Anna-Lovisa brought up the situation for students on grants, and stipends. They can lose their income in case of crises in the home country. Anna-Lovisa mentioned that Erland Liljeroth (vice dean for doctoral education at LTV faculty) is writing a petition to FUR on this matter.

22. Next meeting

Next meeting will take place 13-15 on the 3rd of April

Maria ended the meeting.
